THIS PROJECT WAS MADE POSSIBLE BY PARTNERSHIP WITH THE SEATTLE GARDEN CLUB TO COMMEMORATE THE SEATTLE GARDEN CLUB'S 100TH ANNIVERSARY. IN ADDITION, THE FOUNDATION GRANTED FUNDS TO THE CITY OF SEATTLE FOR A PRELIMINARY DESIGN ANALYSIS FOR A NEW ENVIRONMENTAL EDUCATION CENTER IN THE ARBORETUM. THE FOUNDATION ALSO GRANTED FUNDS TO THE UNIVERSITY OF WASHINGTON BOTANIC GARDENS AND TO THE CITY OF SEATTLE FOR CLEAN-UP, PLANTINGS, REMOVAL OF INVASIVE PLANTS, AND GENERAL BEAUTIFICATION ON LAKE WASHINGTON BOULEVARD NEAR THE RECENTLY COMPLETED ARBORETUM LOOP TRAIL.
