THE FOUNDATION PROVIDES ANNUAL FUNDING TO THE UNIVERSITY OF WASHINGTON BOTANIC GARDENS TO SUPPORT ONGOING HORTICULTURAL CARE AND MAINTENANCE TO THE WASHINGTON PARK ARBORETUM. THIS YEAR'S FUNDING PROVIDED FOR 2 FULL-TIME ARBORISTS, THE EQUIVALENT OF 7 FULL-TIME GARDENER POSITIONS, AND A PLANT PROPAGATOR AS WELL AS IMPORTANT SUPPLIES AND EQUIPMENT.

CAPITAL PROJECTS: THE FOUNDATION EXPENDS FUNDS IN SUPPORT OF THE ARBORETUM'S MASTER PLAN, EITHER THROUGH GRANTING FUNDS TO PARTNERS AT THE UNIVERSITY OF WASHINGTON BOTANIC GARDENS AND THE CITY OF SEATTLE, OR DIRECTLY TO OUTSIDE VENDORS. CURRENT YEAR PROJECTS INCLUDE JAPANESE GARDEN ISHIGAKI WALL CONSTRUCTION PLANNING AND PACIFIC PATHWAYS DESIGN, AS WELL AS ONGOING RHODODENDRON GLEN MAINTENANCE. PRIOR YEAR WORK INCLUDES WOODLAND MEADOW PLANNING, JAPANESE GARDEN PAVILION IMPROVEMENTS, AND THE REPLACEMENT OF THE TSUTAKAWA GATES AT THE ENTRANCE TO AZALEA WAY.

EDUCATION: AS PART OF THE FOUNDATION'S MISSION TO STEWARD THE ARBORETUM FOR FUTURE GENERATIONS, IT PROVIDES VOLUNTEER OPPORTUNITIES, EDUCATIONAL MATERIALS AND FUNDS FOR THE K-12 PROGRAMS RUN BY PARTNERS AT THE UNIVERSITY OF WASHINGTON BOTANIC GARDENS. PROGRAMS INCLUDE AN OUTDOOR PRESCHOOL, SUMMER CAMPS, SCHOOL FIELD TRIPS AND TWO DIFFERENT HIGH SCHOOL INTERN PROGRAMS.
